## **Muensterberg Plaza To Impact Berne For Generations**

n the spring of 2003, the Berne Community Development Corporation (CDC) hired Moake Park, an architectural firm from Fort Wayne. Moake Park's assignment was to prepare preliminary plans for streetscaping along the Main Street and US 27 business corridors, as well as to show how new Swiss facades could



improve these business areas to foster increased tourism. The goal was to help our business districts encourage individuals to stroll, shop and do business.

Moake Park also drew up preliminary plans for a plaza at the corner of Main Street and US 27. The preliminary plan includes a replica of the Bern, Switzerland clock tower. The Berne City Council has given strong continued affirmation for the project as a whole, has committed to transfer the triangular piece of property (old Shell station) to Berne CDC and has committed to vacate State Street to Berne CDC. The plaza will forever improve the appearance of Berne at the crossroads of our community.

#### Improvements Mean Money for Businesses One of Berne's most beautiful

irst Bank of Berne and Bank of Geneva have each agreed to provide up to \$250,000 to Berne businesses that install new Swiss facades. Once the facades are completed, funds may be used for interior improvements. Each qualified business may apply for loans of up to \$40,000 at a rate that is 75% of the Wall Street Journal prime rate, payable over 10 years.

In order for Berne to become a destination marketplace, Berne CDC will work with the City Council to pass an updated and more restrictive signage ordinance that would limit the size, height and illumination of signage in the business corridors.

Berne CDC was organized in 2002 as a 501(c)(3) notfor-profit organization. Our goal is to ensure that present and future businesses in town will not only survive, but will thrive in the ever-increasingly difficult business environment for small town businesses.

The plaza will commemorate and emphasize the values that brought the early settlers to Berne; values such as faith, courage, determination, perseverance, hard work, craftsmanship, generosity, hope, and vision. It will create an enduring legacy for generations to come, and for the thousands who drive by the plaza every day. It will create a visual impact at the "crossroads" of the community that will become nationally, indeed internationally, known.

Join with us as we work to set Berne apart from other small towns so that people will know Berne, Indiana, as a community of distinction and charm.


Wesley Rediger has been hired by Berne CDC to serve as a consultant for the upcoming fundraising campaign.

He has served human service and missions organizations in major metropolitan areas including Philadelphia and Indianapolis, as well as international ministries based in Europe and the Caribbean. He serves on the faculty of various organizational and fund development associations. Prior to founding the consulting firm, Rediger Taylor Group, LLC, he served as VP Development at Huntington College, Director of Student Life at Eastern Mennonite University in Virginia and Area Director with Youth For Christ, Long Island, NY.

## CDC Holds Contests

Each week a new clock photo was hidden in addition to the ones previously not yet found. Once a laminated photo was found of the replica keepsake clock, the sleuths were instructed to go to the Chamber office to claim the prize of an actual keepsake clock.


The contestant had 72 hours to find the answer to the historical trivia. Winners returned to the chamber office within hours of selecting their *Continued on page 4*

Above are depictions of the planned Muensterberg Plaza and Clock Tower. As shown in the map on the right, the clock tower will be situated approximately in the middle of present State Street. To the east of the tower will be north and south event greens as well as a cobblestone walk and water feature with a bear sculpture. To the south of the tower where the original Muensterberg cemetery was located, will be a monument commemorating the original settlers of the community.
